Alcohol Review Committee,

The Nampa Police Department arrested an impaired driver confirmed to have been consuming alcoholic beverages at **Firehouse Sports Pub**, 423 E Karcher Rd, an establishment licensed to sell liquor, beer, and/or wine, where possible violations of Nampa City Ordinance No. 4573 may have occurred. The following is an incident report prepared to be reviewed by the Committee for possible city ordinance and/or license violations.

Nampa Police Incident Report Details

On 07-02-2021 at approximately 11:25 pm, Corporal Poore of the Nampa Police Department arrested an impaired driver who he had observed leaving the Firehouse Sports Pub parking lot, located at 423 E Karcher Rd, in the City of Nampa, County of Canyon. In his probable cause affidavit, Corporal Poore indicated he observed a 2011 Chrysler 300 leave the Getaway Bar and proceed down Karcher Rd to Northside Blvd. Corporal Poore's probable cause for stopping the Chrysler was speeding and failure to maintain its lane of travel. After Corporal Poore stopped the Chrysler, he contacted the male driver where he indicated he could smell the odor of an alcoholic beverage coming from inside of the vehicle. The male driver was the sole occupant. Corporal Poore indicated the driver had the odor of an alcoholic beverage coming from his person, bloodshot glassy eyes and his speech was slurred. The male driver admitted to consuming an alcoholic beverage at the Firehouse Pub. The male driver showed lack of balance, memory, and coordination on all of the Standardized Field Sobriety Tests administered. The male driver provided two valid breath samples for Corporal Poore, .210/.201 BrAC (Breath Alcohol Content). The male was transported and booked into the Canyon County Jail for excessive driving under the influence (Title 18, Chapter 80, Idaho Code).

Nampa Police Incident Report Details

On 07-02-2021 at approximately 12:51 am, Corporal T. Poore of the Nampa Police Department arrested an impaired driver who he had observed leaving the Getaway Bar and Grill parking lot, located at 512 12th Ave Road, in the City of Nampa, County of Canyon. In his probable cause affidavit, Corporal Poore indicated he observed a black, 2014 Ford Fusion leave the Getaway Bar and Grill parking lot and proceed westbound on E Dewey Ave, crossing over 12th Ave Road. Corporal Poore's probable cause for stopping the Ford was failing to maintain its lane of travel and for speeding. After Corporal Poore stopped the Ford, he contacted the female driver where he indicated he could smell the odor of an alcoholic beverage coming from inside of the vehicle. The female driver was the sole occupant. Corporal Poore indicated the driver had the odor of an alcoholic beverage coming from her person, bloodshot glassy eyes, slurred speech, and admitted to consuming alcoholic beverages at the Getaway Bar and Grill. The female driver showed lack of balance, memory, and coordination on all of the Standardized Field Sobriety Tests administered. The female driver provided two valid breath samples for Corporal Poore, .207 / .198 BrAC (Breath Alcohol Content). The female was transported and booked into the Canyon County Jail for excessive driving under the influence (Title 18, Chapter 80, Idaho Code).

The Nampa Police Department arrested an impaired driver confirmed to have been consuming alcoholic beverages at **TNT Dynamites Bar and Grill**, 1411 Shilo Drive an establishment licensed to sell liquor, beer, and/or wine, where possible violations of Nampa City Ordinance No. 4573 may have occurred. The following is an incident report prepared to be reviewed by the Committee for possible city ordinance and/or license violations.

Nampa Police Incident Report Details

On 07-02-2021 at approximately 2334 PM, Officer Tucker of the Nampa Police Department arrested an impaired driver who he had observed leaving the TNT Dynamite Bar and Grill parking lot, located at 1411 Shilo Drive, in the City of Nampa, County of Canyon. In his probable cause affidavit, Officer Tucker indicated he observed a White 2004 Volvo leave the TNT Dynamite Bar and proceed down Franklin Blvd and west on Karcher Rd near Delta Dr. The vehicle was traveling west on E Karcher Rd at 40 MPH in a marked 35 MPH zone. After Officer Tucker stopped the Volvo, he contacted the female driver where he indicated he could smell the odor of an alcoholic beverage coming from inside of the vehicle. The female driver was the sole occupant. Officer Tucker indicated the driver had the odor of an alcoholic beverage coming from her person and bloodshot glassy eyes. After stopping the vehicle Officer Tucker could see, what he described as an alcoholic beverage in the center console of the vehicle. As he spoke to the female driver, she became combative and fled. A pursuit ensued down E Karcher Rd to Marketplace. The female driver slowed and continued down to Midland Blvd and then north on Midland to Cherry Ln. The vehicle continued to Middleton Rd and Cherry Ln where Officers were able to take the female driver into custody. The female driver refused to perform Standardized Field Sobriety Tests. Officer Tucker as able to secure a blood draw warrant after speaking with a judge. Officer Tucker did state in his report the female admitted to consuming alcoholic beverages at the TNT establishment as well as leaving with the drink she ordered form the bar that was in her vehicle. After a blood draw was performed, the female was transported and booked into the Canyon County Jail for driving under the influence – refusal (Title 18, Chapter 80, Idaho Code), eluding (Title 49, Chapter 14, Idaho Code), open container by driver (Title 23, Chapter 5, Idaho Code), possession of a controlled substance (Title 37, Chapter 27,

Idaho Code), possession of drug paraphernalia (Title 37, Chapter 27, Idaho Code), and resist and obstruct (Title 18, Chapter 7, Idaho Code).



Alcohol Review Committee,

Upon review of the of the Incident Report submitted to the Alcohol Review Committee by Lieutenant Jamie Burns the City Clerk's Office would like to note an error in the report and also report possible violations of Nampa City Ordinance No. 4573 which may have occurred. The following is an incident report prepared to be reviewed by the Committee for possible city ordinance and/or license violations.

Report Details

The City Clerk's Office would like to report that while TNT Dynamite Bar Grill (hereafter: TNT) holds a valid City alcohol license for their establishment located at 817 E Karcher Rd. (Exhibit A) they do not hold a valid 2021-2022 license authorizing the sale of alcohol at an establishment located at 1411 Shilo Drive. It should be also noted that TNT held a valid license for the 1411 Shilo Drive location for the 2020-2021 license year, this license expired on May 31, 2021 and was not renewed. Furthermore, no catering permits were issued to TNT authorizing the sale of alcohol on July 2nd at 1411 Shilo Drive.

11. Sex Crimes: Any action or conduct which violates any provision of Title 18, Chapters 15 and 66, Idaho Code. **6.5 Points.**
12. Occupancy: Exceeding Occupancy load for the premises as stated on the occupant load limit sign posted in the premises or failing to post the occupant load limit sign for the premises in a conspicuous place near the main exit or exit access doorway of the premises. **.5 to 2.0 Points.**
13. Open Containers: Allowing a person to exit the licensed premises while possessing an open container of alcoholic beverage. **.5 to 1.5 Points.**
14. Right-of-Way Encroachment: The licensee violates any provision of a right-of-way encroachment license. **.5 to 1.5 Points.**
15. Hours of Operation: The licensee violates hours of operation as defined in Section 5-12-13, Nampa City Code. **.5 to 1.5 Points.**
16. Property Maintenance: The licensee violates the International Property Maintenance Code, as adopted by Title 4, Chapter 11, Nampa City Code. **.5 to 1.5 Points.**
17. General Violations: All other violations of law or the City Code. **.5 to 3.5 Points.**
18. Site Specific DUI: A patron of a Licensee that receives a DUI in Nampa City limits immediately following his/her leaving the Licensed premises, and under facts and circumstances that give law enforcement credible evidence that the cause of the DUI was alcohol consumed from the licensed premises. **1.0 to 4.0 points**

The City Clerk' Office requests the Committee meet to review this report, the Alcoholic License Point System (ALPS) listed above and determine whether there is probable cause to believe that a licensee or an employee or agent of a licensee committed a license violation, and if so, determine the points appropriate for violations that may have occurred.
