

Articles of Incorporation of theampa
Land and Improvement Company.

Know all men by these presents: That
we, the undersigned have this day vol-
untarily associated ourselves together
for the purpose of forming a corporation
under the laws of the Territory of Idaho,

And we hereby certify:

First

That the name of said corporation
is theampa Land and Improvement
Company.

Second

That the purposes for which it is
formed are to locate and own towns
and town sites, to buy and sell real
and personal property, to buy and erect
buildings for sale or for rent, to
erect or construct ditches and water
works in connection with and for
the use of said towns as may be nec-
essary or convenient therefor, in Idaho
Territory.

Third

That the place where its principal
business is to be transacted shall
be the town ofampa, County of Ada,
Territory of Idaho.

Fourth

That the term for which it is to exist is
fifty years from and after the date of its Incorporation.

Fifth

That the number of its Trustees shall be three and the names and residences of those who are appointed for the first three months are:

- James A. McGee, Caldwell, Ada County, Idaho.
- Alexander Duffes, Kampa, Ada County, Idaho.
- James M. Stewart, Portland, Multnomah County, Oregon.

Sixth

That the amount of the Capital Stock of this Corporation shall be Twelve thousand (12,000) Dollars divided into one hundred and twenty (120) Shares of the par value of one hundred (100) dollars each.

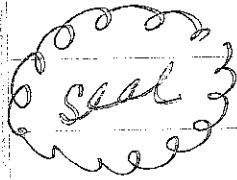
