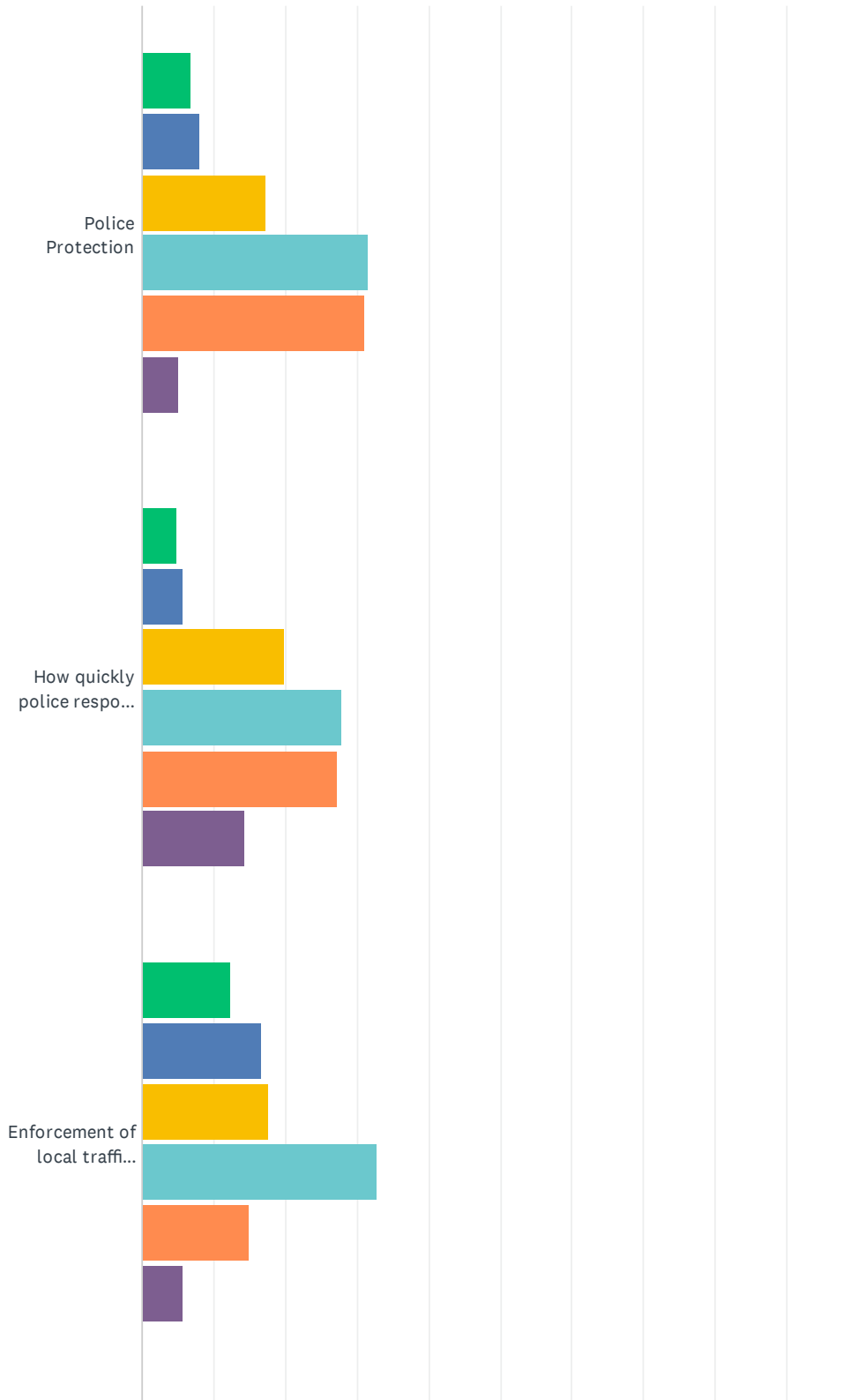

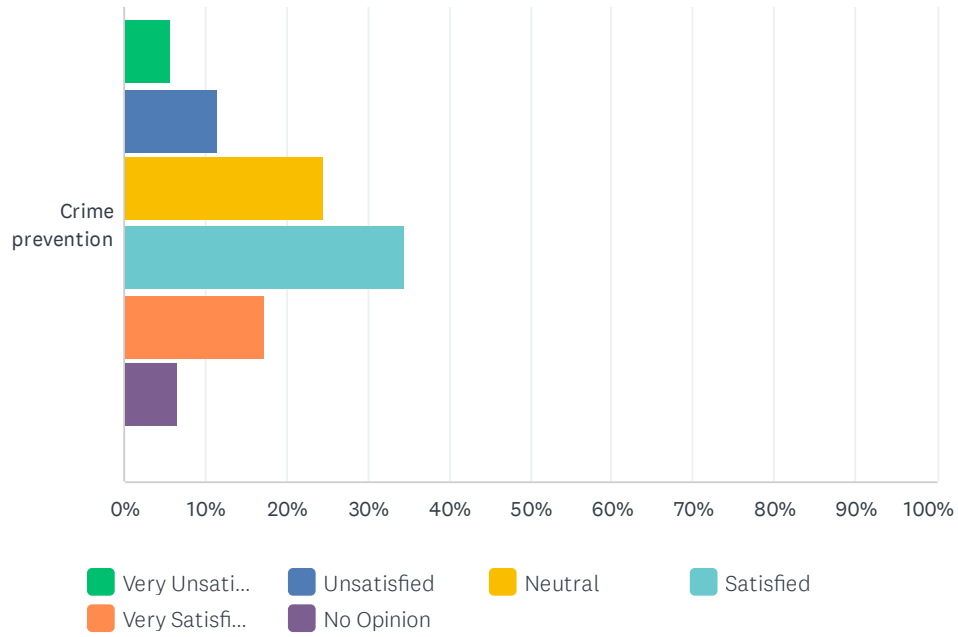

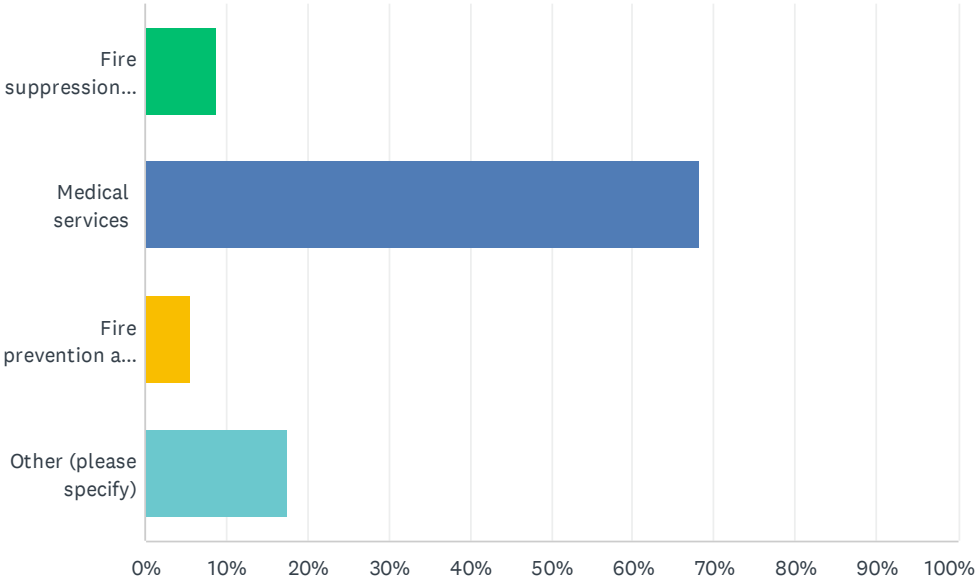

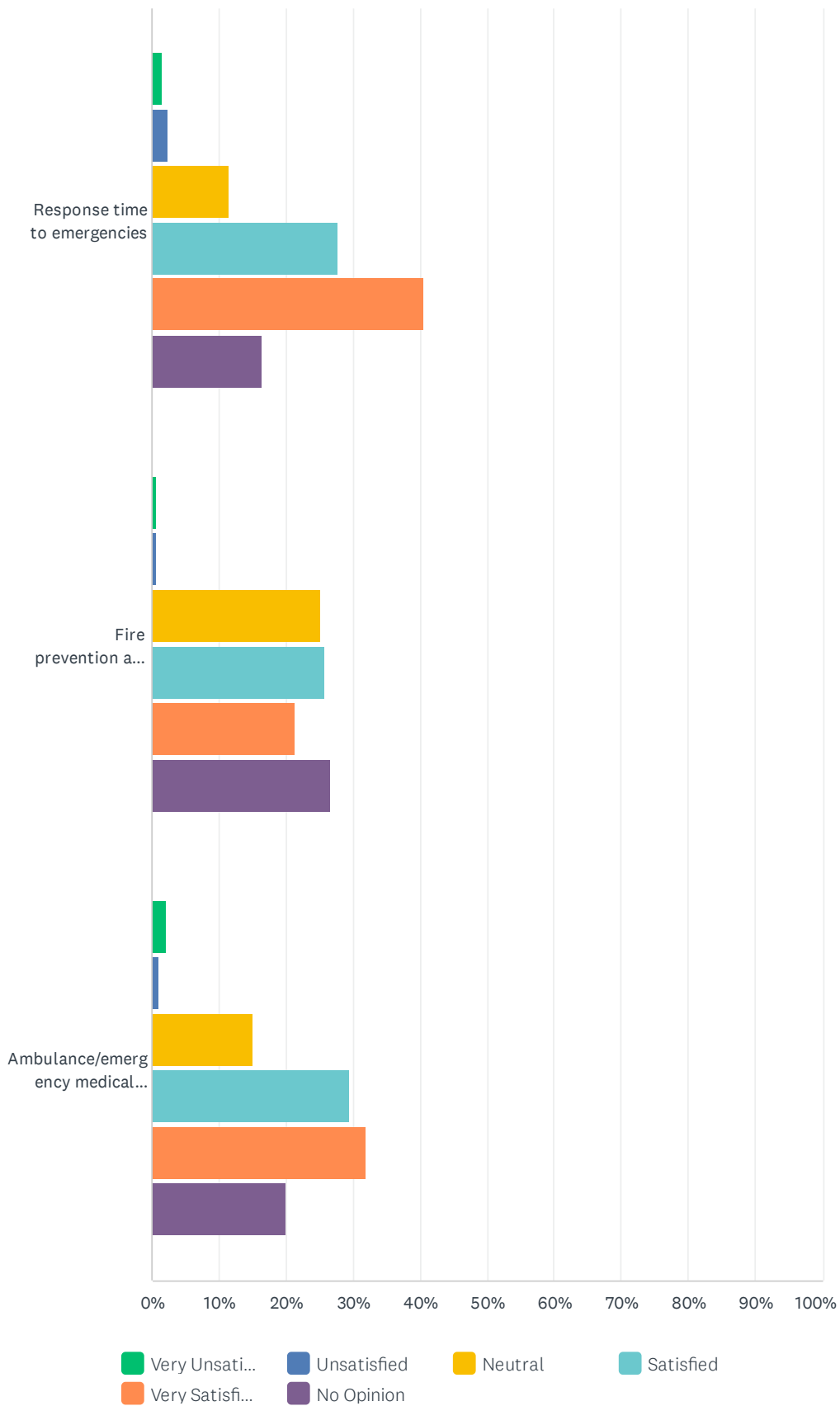

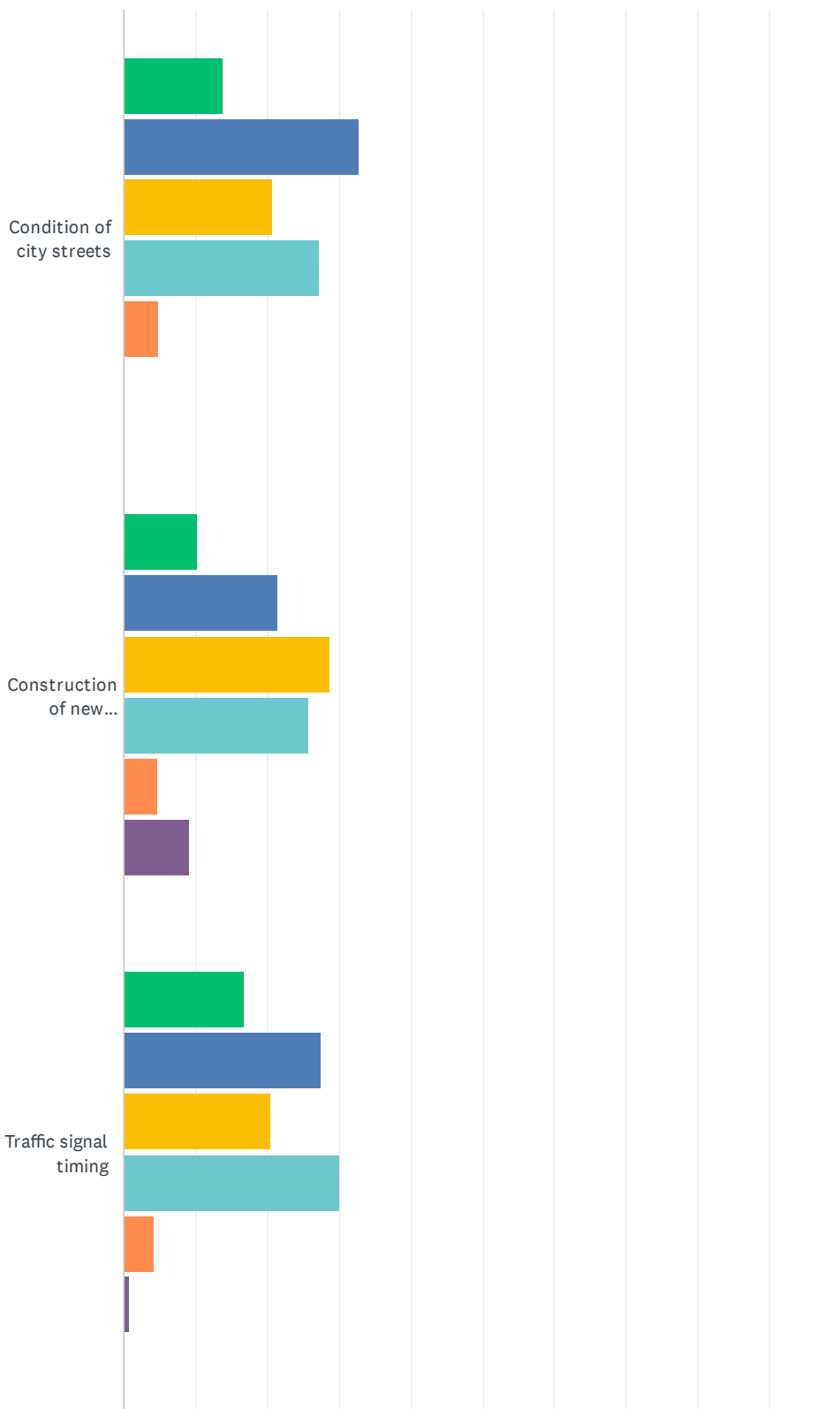

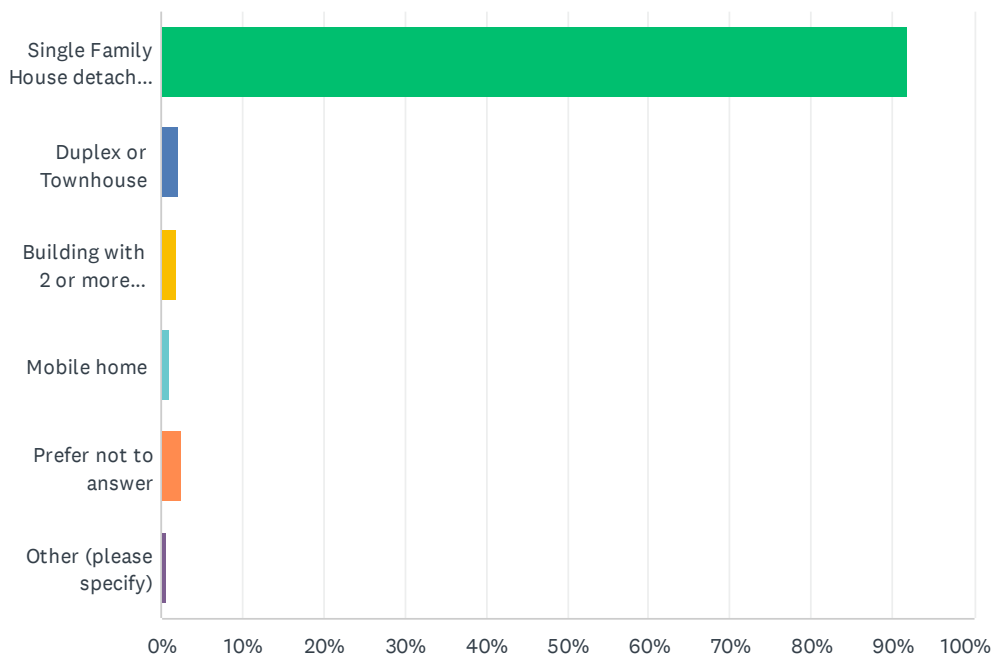

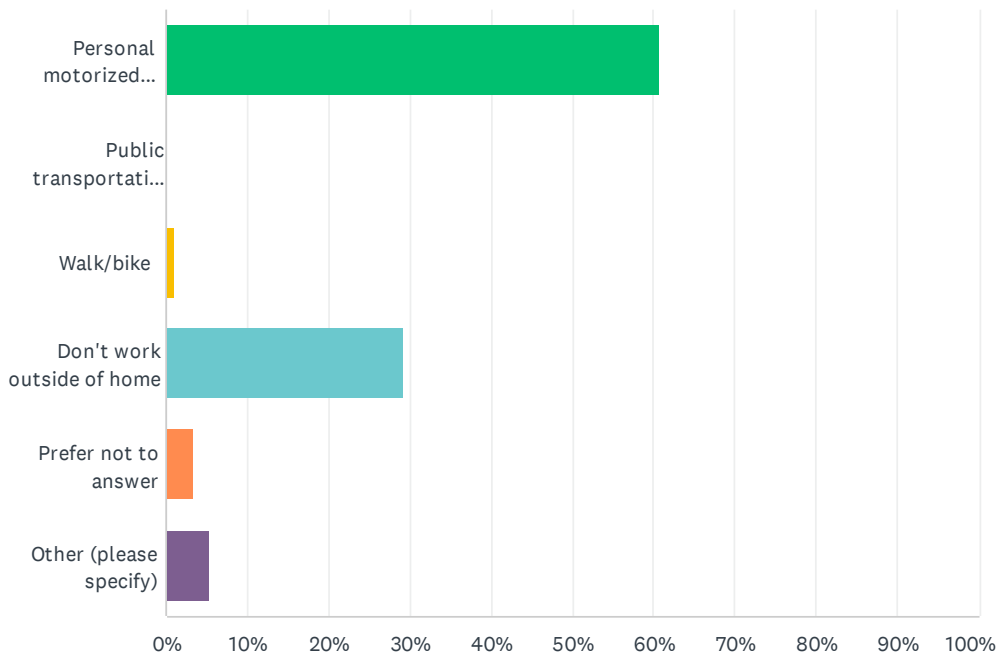

Q29 By what method do you commute to work?

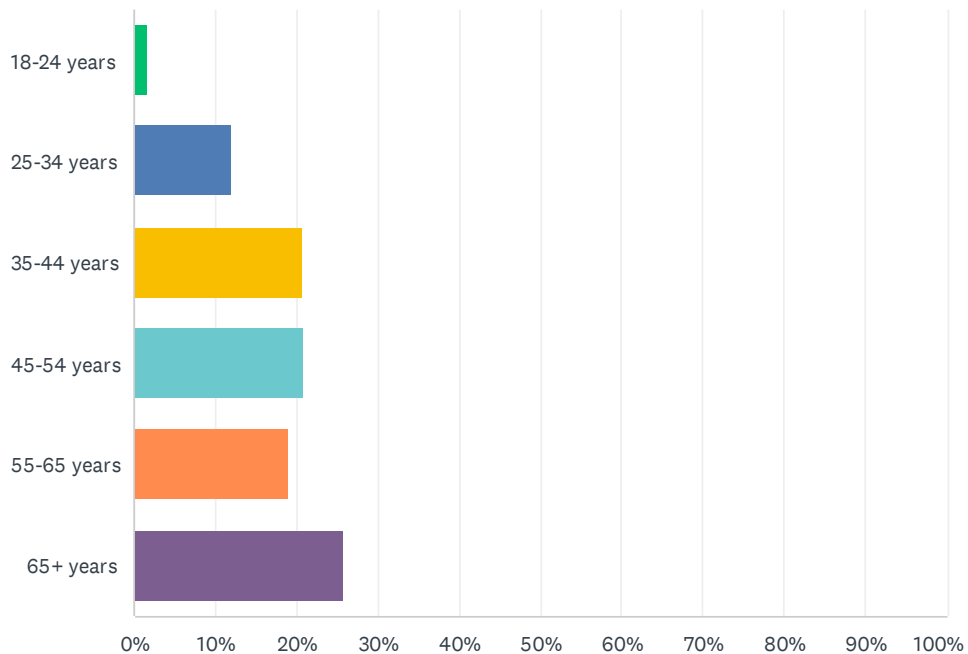

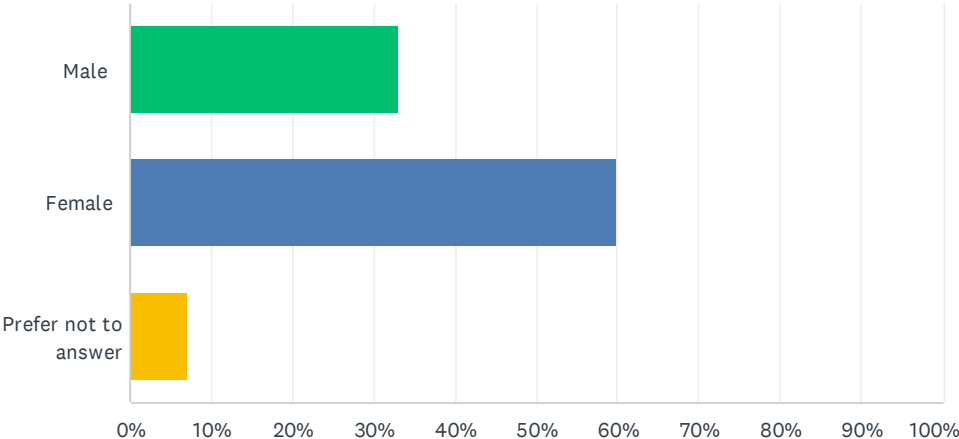

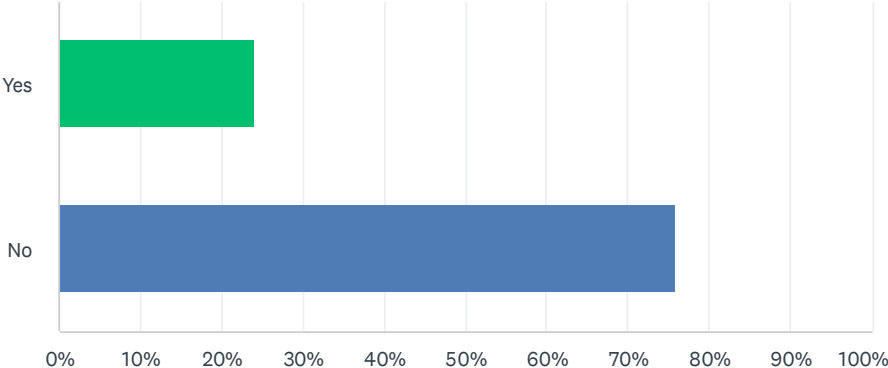

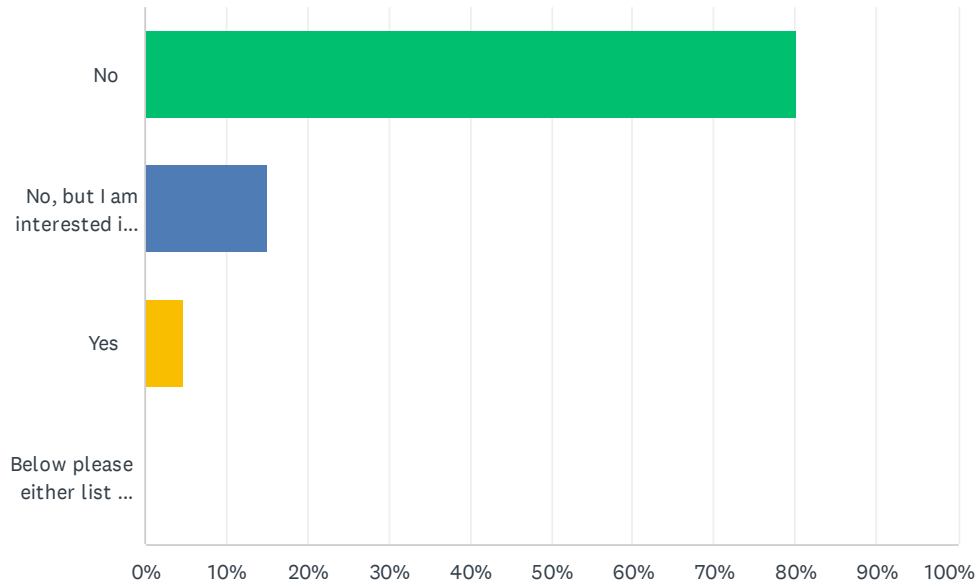
