Stamp or write the date and time of receipt on the front of the Declaration of Candidacy and Petition of Candidacy. 4. Complete the fields and statement below. 5. Transmit a copy of this Certification along with a copy of the Declaration of Candidacy to the County Clerk for ballot preparation.

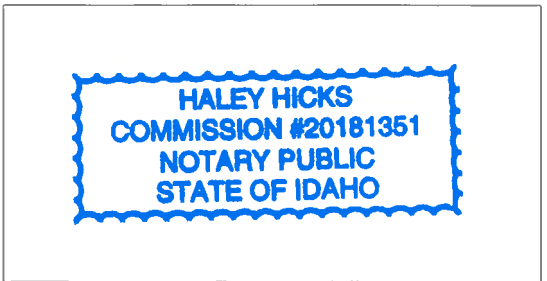


