Paint and supplies are provided through the program.

This is a free event for both teams and homeowners.



ELIGIBLE CANDIDATES MUST:

- Be at least sixty (60) years old, or
 - Disabled (no age qualifications, but all other criteria apply);
- AND
- Own and live in the home you wish to have painted
 - Be unable to afford painting costs
 - **Applicant MUST provide documentation of Income (see below)**
 - The home or property must be in NEED of paint
 - Home must be located within Nampa City Limits and in compliance with Code Enforcement

We are required to ensure and keep record that we are serving clientele that need the help financially from Brush-Up Nampa. We ask that you please include the following items with your application. If you have additional people living in your home besides you and your spouse, we need to have these documents for them too, where applicable. Thank you!

Applications that do not have the following items will not be eligible until accounted for.

- Latest tax returns (if you file) Or W-2's if most recent tax return hasn't been prepared (if you work)
- Last 2 pay stubs from each working person in the household.
If not applicable, verification of any other form of Income, or signed statement of no income
- Annual social security & disability/pension statements
- Verification for any other sources of income
- Last 2 months of bank statements
If no bank account, letter stating so with signature and date
- Signed lead-based paint notice, if applicable (attached)

You may bring in originals of these documents and we will help you make copies for our records, or you may bring in or mail copies with your application. All documentation of income will be kept under lock and key, and any account numbers will be blacked out.

LEAD BASED PAINT

Housing built before 1978 may contain lead-based paint. Lead paint dust, chips, and contaminated soil can be harmful to young children and pregnant women if safe practices are not followed. Volunteers will identify tasks on each project where children and pregnant women should be excluded because they may be exposed to lead dust.

Volunteers have been advised of the following safety steps to follow regarding lead-based paint:

1. Wet down the siding with a garden hose prior to any scraping (this helps to eliminate any airborne paint dust)
2. Wear Respiratory Protection (masks) provided by the City any time you are disturbing existing paint (like scraping, sanding, or using a wire brush).
3. Place plastic drop cloths (provided by Brush-Up Nampa) under each area of the home that you are prepping. When scraping, any paint chips from the wall should be collected in the drop cloths and disposed of in the provided trash bags and not left in the soil surrounding the home.
4. Tie off the trash bags when finished and double-bag the debris. Please separate from regular trash left on the curb for collection.

**If you have young children or pregnant women living in or visiting your home at the time of prep work or painting, please ensure that they are away from the work being done while the old paint is being disturbed. Please notify the volunteer team leader if you have a pregnant woman or young children staying with you.*

In consideration of the opportunity afforded me to have my house painted through Brush-Up Nampa on a voluntary basis, I hereby waive any rights or case of action arising as a result of my or my family's participation in said project from which any liability may or could occur against Brush-Up Nampa officers and directors collectively or individually, event sponsors, donors, volunteers, or homeowners. Without limiting the generality of the foregoing, I agree that this waiver shall include any rights or causes of action resulting from personal injury to me or my family member sustained in connection with my activities for Brush up Nampa.

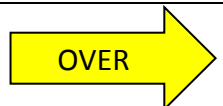
